I/We, both individually and for the Customer, agree to provide HE a separate

In the event HE extends credit to Customer in reliance on this Credit Application, I/we, both individually and for the Customer, understand and agree to promptly pay all charges within 30 days of the invoice date and agree that HE may assess interest and services charges on Customer's outstanding balance at a rate of 1.5% per month (18% per annum). In the event that payment is not timely made, the undersigned, both individually and for the Customer, further agree to pay all costs of collection, including attorney fees, in the event Customer's account is turned over to an attorney for collection. I/We further agree that the Terms and Conditions of Sale attached to this Application are applicable to and shall govern each sale transaction between Customer and HE. It is agreed that this Credit Application will be governed under the law of the State of Georgia. HE has the option of pursuing an action under this Credit Application in any court of competent jurisdiction in the State of Georgia, and I/we consent to venue and jurisdiction in the State of Georgia. It is agreed that HE shall retain title to any goods sold until payment in full has been received. The undersigned further agree to be personally responsible as guarantor for any purchases made by the customer. HE reserves the right to withdraw credit immediately, or not to extend credit to the Customer at its sole discretion at any time.

- 1. Acceptance of Order; Termination.** Acceptance of any order is subject to credit approval and written acceptance of order by Heyden Enterprises, LLC ("HE"). If credit of the Customer becomes unsatisfactory to HE, then HE reserves the right to terminate upon notice to Customer without liability to HE.
- 2. Limitation of Liability.** All goods sold to Customer are sold "AS IS," and HE disclaims any implied warranties with respect to the goods, including, but not limited to, any warranty of merchantability or fitness for a particular purposes. Further, HE's liability for breach of this agreement or any damages caused by defective, damaged, or malfunctioning goods sold to Customer by HE shall be limited to either repair or replacement of the goods or refund of the purchase price, all at HE's option, and **IN NO CASE SHALL HE BE LIABLE FOR INCIDENTAL, SPECIAL, OR CONSEQUENTIAL DAMAGES.**
- 3. Indemnification.** Customer shall defend, indemnify, and hold harmless HE and its agents, employees, successors, and assigns from and against all claims, losses, damages, expenses, or costs, including attorney's fees, arising out of or relating in any manner to this Credit Application or any labor, materials, goods or services purchased by Customer from HE, excluding claims attributable to the sole negligence of HE.
